Scope Review\*







Stokes Equipment Company (SECO) will remove the existing air curtains on both sides of the existing Rytec doors, metal shrouds/hoods, activation devices, conduit, photo eyes and componentry. The bollards and guardrail will remain in place. Currently, SECO is excluding removal or re-piping of the white PVC process pipes that are built around the Rytec door front hood. Stokes, if requested, can contract an approved Samuel Adams vendor who handles their processing equipment to provide a pre-approved new route for the PVC pipe based on the future layout of the Fastrax LD doors. Advise who SECO should reach out to if this is requested to be added to the contract. SECO will dispose of all material and debris in dumpsters provided by Samuel Adams. SECO will complete control wiring from a supplied disconnect located at the existing position. All wiring to be completed in factory seal tight and/or flex cable. Rigid conduit is not included.

If Saturday labor or Sunday labor is required, see the details noted above for additional mobilization costs. Once a scope is approved by Samuel Adams a finalized proposal can be provided. Equipment rental is based on a single continuous 1-month rental period.

If purchaser does not take delivery within 150 days, seller shall have the right to increase prices on account of cost increases. In either event, seller must give purchaser reasonable notice of proposed price increases and purchaser shall have the right to cancel this agreement without penalty within 15 days after receipt of such notice.




